To apply for a replacement salvage title in Oregon, the owner must certify by completing and signing the statements below. Under Oregon law, it is a crime to knowingly make any false statement on an application for title (ORS 803.070 / ORS 803.385). Both offenses are Class A misdemeanors and are punishable by a jail sentence of up to one year, a fine of up to \$6,250 or both.

### I certify:

- The original salvage title issued for this vehicle has been lost, destroyed or mutilated, and to the best of my knowledge has not been signed, conveyed or transferred to another party. If mutilated, the title or what remains of the title is attached.
- The information on this application is true and correct.

• **WHEN TO USE THIS FORM** •

Use this form if your salvage title has been lost, destroyed, or mutilated.

**To apply for a replacement salvage title with NO CHANGE in ownership:**

1. Complete the front of this application. See instructions below for required signatures.
2. Submit the completed application to DMV with a fee of \$27.

**CERTIFICATIONS / SIGNATURES**

This section on the application **must** be completed to request a replacement salvage title and to certify that the last salvage title issued for the vehicle was lost, destroyed, or mutilated.

All owners shown on **DMV** records **must** sign the application for a replacement salvage title. Signatures of registered owners are required even if they have released interest.

If the owners of record cannot certify what happened to the title, the person who can certify this **must** sign Line 12 in addition to the owner's signature.

**To apply for a replacement salvage title with any change in ownership:**

You must first determine whether an odometer disclosure is required with the transfer. (See exemptions below.)

**Transfers exempt from odometer disclosure:**

- Any transfer where at least one registered owner is remaining the same.
- Any transfer of:
  - Vehicles ten years old or older (for example, a 1994 vehicle is exempt as of January 1, 2004);
  - Vehicles with a manufacturer's gross vehicle weight rating of more than 16,000 pounds;
  - Snowmobiles;
  - Class I All-terrain vehicles;
  - Trailers; and
  - Vehicles not equipped with an odometer at the time of manufacture.
- A transfer of a salvage title when an odometer disclosure is impossible to provide. (Attach a statement from the owner indicating the reason.)

**If an odometer disclosure is required:**

A replacement and transfer with a complete change in ownership is **not** allowed.

- You must first obtain a replacement salvage title with at least one registered owner remaining on the title. The registered owner must then complete the odometer disclosure on the back of the title. (See instructions above for required signatures.)
- If the change in ownership does not require an odometer disclosure, follow instructions below for a transfer of ownership.

**If an odometer disclosure is NOT required:**

1. Complete the replacement application. See instructions above for required signatures. **NOTE:** DMV will accept a replacement title transaction with a change in ownership, without the owner of record's signature (Lines 10 and 11), only when no odometer disclosure is required and all ownership releases are provided. Attach a release of interest from all parties shown on DMV records who will not be shown on the new title.
2. Complete the appropriate application (Application for Title [Form 226] or Application for Salvage Title [Form 229] showing how the new title is to be issued.)
3. Submit both applications, the releases and the fee of \$27 to DMV. **NOTE:** If a regular title is applied for (Form 226), other requirements and fees are necessary.
