- 1) Transporter plates will be issued to transport vehicles (ORS 822.310):**

### USE OF TRANSPORTER PLATES

- Transporter plates can only be used to transport vehicles that are for sale.
- A transporter plate must be displayed on the rear of the vehicle being driven or towed.
- Transporter plates can not be used on a power unit that is towing a vehicle. Towing is an activity subject to a towing business license.
- Transporter plates are not intended to be used on any commercial vehicles or any vehicles carrying a load.
- Any other movement of a manufactured structure must be by a manufactured structure trip permit.

## ADDITIONAL INFORMATION ON TRANSPORTER PLATES

**Lost/Missing/Stolen Transporter Plate(s):** To report a lost or missing plate, write to DMV Business License Unit at 1905 Lana Ave NE, Salem OR 97314, or fax to 503-945-5289. Specify the alpha character of the lost or missing plate. This can be reported at any time during your license period, or at renewal time on your transporter plate list.

**Purchasing Additional Plate(s):** To purchase an additional plate(s), send your request and \$17 per additional plate to DMV Business License Unit at 1905 Lana Ave NE, Salem OR 97314. Additional plates can be ordered at any time during your license period and at renewal time.

**Reciprocity with other jurisdictions:** Oregon grants reciprocity on transporter plates to nonresident operators from the following states:

# Instructions for Completing a Transporter Application for a Vehicle Transporter Certificate

(Originals and Renewals)

**Legal Name** - If your business is a sole proprietorship, list your full name as the legal name. If your business is a partnership, list the full names of each partner or the partnership name. If your business is an LLC, list the name of the limited liability company (includes "LLC") registered with Business Registry. If your business is a corporation, list the name of the corporation (includes Inc, Corp, etc.) registered with Business Registry.

**Business Name** - If using an assumed business name or trade name, list the business name registered with Business Registry.

**Oregon Registry Numbers** - If you do not know your Oregon registry number(s), contact Business Registry at 503-986-2200.

**Business Location** - List the main business location of your transporting business.

**If main location is outside Oregon -**

- List any Oregon location(s) on Lines 5 and 6.
- Attach a copy of your certificate, license, permit or similar document from the jurisdiction of your main location (state listed on Line 3).

**Type of Organization** - Check your organization type and if a corporation, list the state under whose law the business is incorporated.

**Use of Transporter Plates** - Give explanation on how your transporter plate(s) will be used. You need to be specific. Transporter plates have limited uses so see the section under "Transporter Plates" for additional information.

**Registered Agent** - If your business is an LLC or a corporation, the registered agent's name, street address and mailing address is required

**Ownership/Applicant's Certification Signature** - Provide name, residence address, mailing address and signature of owner, partners, LLC members or corporate officers on Page 3 (do not list CEOs, Chairs of the Board, General Managers, Directors, et al). Every applicant listed on the application must provide a certifying signature.

**Please attach (staple) copies of ALL owners, partners, LLC members or corporate officers official photo ID's (driver license or state issued identification cards ONLY) to your application.**

**Plate Billing List and Calculation sheet** - If renewing, follow the instructions on the calculation sheet for fees and submit both the calculation sheet and plate list with your renewal.

Read all parts of the application before completing it. Your application will be returned to you if any part is incomplete or missing.

When submitting your application and fees at the customer service counter:
