MOTOR HOME SCHEDULE OF REGISTRATION FEES

- Motor home registration fees are calculated using the Fee Schedules set forth below, according to length (any fractions will be rounded down to the full foot), and **either** the initial registration date **or** the date the registration expires.
- **Initial Registration:** The fee for initial motor home registration shall be determined by the registration date. For initial registration (**before January 1, 2008**) of motor homes 6 – 14 feet in length, refer to “Fee Schedule A.” For initial registration (**after December 31, 2007**) of motor homes 6 – 14 feet in length, see “Fee Schedule B.” To determine the initial registration fee for all motor homes over 14 feet in length refer to “Fee Schedule C.”
- **Expiration Registration:** The registration fee for motor homes 6 – 14 feet is determined by the date the current registration expires or when the registration period begins. Registration fees for all motor homes 6 – 14 feet in length with current registration that expires before January 1, 2008 or with registration periods beginning before January 1, 2008 shall be paid according to “Fee Schedule A.” Registration fees for all motor homes 6 – 14 feet in length with registration expiration dates or registration periods beginning after December 31, 2007 shall be paid according to “Fee Schedule B.” Registration fees for all motor homes over 14 feet in length shall be determined according to “Fee Schedule C,” **regardless of the registration expiration date.**

- To qualify for motor home registration, the vehicle must be designed, reconstructed, or permanently altered to provide facilities for human habitation (permanent sleeping and cooking facilities). Permanently mounted campers on pickup or truck frames must be registered as motor homes.
- Motor homes are registered for a two-year period and may not exceed 45 feet in length. If a motor home does not already have motor home plates, a plate fee is also required.
