# ANTIQUE / SPECIAL INTEREST VEHICLE DECLARATION FOR REGISTRATION

## SECTION 1 (Completed by Owner)

**Check the box that applies:**

- A. This vehicle is an ANTIQUE VEHICLE. It is a vehicle older than half the number of years between the current year and 1900. (To determine the year model eligible for registration as an Antique Vehicle, subtract 1900 from the current year. Divide the number by two. The vehicle must be this year model or older); or
- B. This vehicle is a SPECIAL INTEREST VEHICLE. It is a vehicle with a year model at least 25 years old as dated from the current year; or
- C. This vehicle is a SPECIAL INTEREST VEHICLE. It is a vehicle that has been sanctioned by an established organization as a vehicle of special interest. The representative of the established organization must complete the section at the bottom; or
- D. This vehicle is a SPECIAL INTEREST VEHICLE. It is a vehicle that was manufactured prior to 1949 or was manufactured to resemble a motor vehicle manufactured prior to 1949 and meets the definition of STREET ROD in ORS Chapter 801. It is not a motorcycle or an assembled vehicle; or
- E. This vehicle is a SPECIAL INTEREST VEHICLE. It is a vehicle that meets the definition of a racing activity vehicle as defined by ORS Chapter 801.

I declare the vehicle described above is to be maintained as a collector's item used for exhibitions, parades, club activities and similar functions. I further understand that operation of this vehicle outside of the limitations of the registration provisions as specified in ORS 805.030 is a Class D traffic infraction and may result in this registration being canceled.

I understand that, if I discontinue antique/special interest registration on this vehicle, I may not use the antique/special interest plates (whether issued by DMV or provided by me) as registration plates on this vehicle.

I understand it is a crime under ORS 803.385 to certify the truth of a statement when I know it is not true. Such a crime is a Class A misdemeanor and is punishable by a jail sentence of up to 1 year, a fine of up to \$6,250 or both.
