Full completion of this form only places a notation on the vehicle record. **This form cannot be used as a bill of sale.** Owner name(s) on DMV records cannot change until the title is submitted for transfer. Purchaser must apply for title to the vehicle within 30 days of purchase or pay a late penalty fee (ORS 803.090).
