The maximum size of the fleet you operate under IFTA determines the total amount of your license fee for the year. If you are ordering more decals because the number of IFTA-qualified vehicles you operate outside of Oregon has increased, your license fee will increase. You pay the difference between the total fee for the number of vehicles you are now operating, and the amount you have already paid. (For example, if you have been operating 6 vehicles, and have paid \$355 in license fees previously, and you are now adding 3 vehicles, your total license fee will be \$400. Subtract \$355 already paid from the new fee of \$400, and pay the \$45 difference.)

Enclose the required fee based on the number of qualified vehicles you operate under IFTA.

Note: Application will not be processed if the required fee is not included.

IFTA License fees are charged for the whole calendar year, regardless of how short a time you may operate during the year. If your IFTA-qualified fleet increases, your license fee for the year increases, to a maximum of \$575. Fees are based on the highest number of IFTA-qualified vehicles you operate during the year, and are not refunded if your fleet decreases in size. The size of the fleet that you operate under IFTA is the number of IFTA-qualified vehicles you operate outside of Oregon. (Please see definition for a qualified motor vehicle on the other side of this page.) You will need a pair of decals for each vehicle. Place one decal on the door of each side of the vehicle and carry a copy of the IFTA License in the cab of each vehicle.

Replacement decals

If you are ordering more decals because you have sold a vehicle and need new ones for the new vehicle you are operating, or have other reasons for needing replacement decals, you will need to explain this in the space provided below. As long as the size of your fleet has not increased, your IFTA License fee does not increase, and no payment is required.

***FARM:** The farm rate for IFTA License fees is based on the number of IFTA-qualified vehicles you operate outside of Oregon, and how many of those vehicles are registered with Oregon as farm vehicles. If you have paid the Farm fee and more than half of your IFTA-qualified vehicles are Oregon farm plated, no additional license fee is due. (See the definition for a qualified motor vehicle, below.) You will need a pair of decals for each vehicle. Place one decal on the door of each side of the vehicle and carry a copy of the IFTA License in the cab of each vehicle.

If half or more of all of your IFTA-qualified vehicles are not farm-plated, you no longer qualify for the farm rate. You must use the form on the other side of this page, and enclose the difference between the fee for the total number of vehicles you now operate under IFTA, and the \$50 license fee you have already paid. IFTA License fees will not be refunded regardless of the number of vehicles that are farm-plated later during the same year.

Your qualification for the farm rate may be verified at the time additional decals are issued, or at a later date. If we have issued additional decals to you and we find that you do not qualify for the farm rate, you will be charged additional license fees accordingly, based on the total number of vehicles you operate. (See the license fee chart on the other side of this page.) For the purpose of confirming your Farm certification, please include your Farm ID Number in the space provided above.

"Qualified Motor Vehicle" means a motor vehicle used, designed or maintained for transportation of persons or property and

1. having two axles and a gross vehicle weight or registered gross vehicle weight exceeding 26,000 pounds; or
2. having three or more axles regardless of weight; or
3. is used in combination, when the weight of such combination exceeds 26,000 pounds gross vehicle weight or registered gross vehicle weight. If a vehicle qualifies in combination, all operations must be reported for the license year.

"Qualified Motor Vehicle" does not include recreational vehicles.
